BACKGROUND

The City's Cultural Policy provides for a review process for applicants to the Cultural Organizations Program (COP) in the Cultural Program section, I(A)4. The policy states, in part, that, "following initial review by the Office of Cultural Affairs Staff, eligible applications are evaluated by an advisory panel composed of a diverse group of artists, representatives from cultural institutions and organizations, and representatives from the community at large who are given specific direction and orientation to enable them to fairly review applicant proposals." The FY 2018-19 COP guidelines provide that membership for the peer review panel is taken from a list of qualified candidates nominated from the sector and approved by the Cultural Affairs Commission.

This action recommends adoption of a list of qualified candidates that may be called upon to serve on the FY 2018-19 COP review panel. Names appearing on this list do not represent the final membership of a review panel.

SUBJECT

Recommendation to adopt a list of candidates for future Public Art selection panels for the period May 1, 2018 through April 30, 2019

BACKGROUND

The City of Dallas Public Art Ordinance (Dallas City Code Section 2-105) provides for the responsibilities of the Public Art Committee (arts committee), which includes, in part, for "the selection of juries (selection panels), to be composed of professionals in the visual arts and design fields and members of the community, who will recommend artists and artworks of the highest quality." Furthermore, the ordinance provides that the Cultural Affairs Commission must approve the recommendations of the Public Art Committee, including as it relates to juries (selection panel). The City's Cultural Policy (Section III.E.3.) provides for the composition for these panels.

In February 2016 the Public Art Committee and Cultural Affairs Commission recommended adoption of selection panel guidelines, which are attached for reference.

This action recommends adoption of a list of qualified candidates that may be called upon to serve on future Public Art selection panels for the period May 1, 2018 through April 30, 2019. Names appearing on this list do not represent the final membership of review panels.
