## **SUBJECT**

Recommendation in support of artist Seth Vandable for a commission of artwork at Pike Park, located at 2807 Harry Hines Boulevard, in tribute to Santos Rodriguez – Total not to exceed \$59,348.00 – Financing: 2017 Bond Funds (\$59,348.00)

#### **BACKGROUND**

Pike Park, named after Edgar L. Pike, was formally dedicated in 1927. The park is located in the neighborhood known as Little Mexico, which was home to many Mexican-American families in the early decades of the 20th century.

On October 18, 2018, the Park and Recreation Board authorized naming the field house at Pike Park as "Santos Rodriguez Center at Pike Park." The artwork will honor the life of Santos Rodriguez with narrative references to the events surrounding his death on July 24, 1973. See related articles on Santos Rodriguez:


Artist Seth Vandable was recommended for this public art project by the Selection Panel composed of artists, community members, a member of the Santos Vive project, and a representative from the Park and Recreation Department. The location within the park is a garden area (formerly a pool) near the playground and the basketball court.

## Artist Background:

Seth Vandable began his career as a commercial artist and painter in Central Texas. His background in painting combined with many years of studying human anatomy contributed to his international success as a sculptor. Vandable strives to capture the intensity of the human spirit in compositions that are both innovative and timeless. His work can be found in private and public collections worldwide.

## **Project Description:**

The figurative bronze sculpture would be approximately 8 ft. tall, with a life-size child figure modeled after Santos Rodriguez placed above stylized figures. To create the proposal, the artist conducted extensive research into the death of Santos Rodriguez and its aftermath. His research included speaking with people involved with Santos Vive Project, Santos' family, and community members leading the efforts to honor Santos Rodriguez. In his proposal, the artist seeks to address the tragedy so that the new artwork can help move the city forward.
