Meeting Attendance Requirements

- Dallas City Code Section 8-20 provides for attendance requirements for all City boards and commissions
 - A member of a board that meets monthly, who is absent from more than 25 percent of the regular meetings during any 12-month period, <u>whether</u> <u>excused or not</u>, shall result in a forfeiture
- For the Cultural Affairs Commission, typically <u>3 absences</u> during any 12-month period will result in forfeiture (typically 10 regular meetings per year)

Additional Meeting Attendance Requirements

- Dallas City Code Section 8-21 requires that:
 - A member who leaves a board meeting after the board has been duly called to order and is absent for the remainder of the meeting, without first obtaining the consent of the chair, shall be charged with an unexcused absence for that meeting. The consent of the chair may be given only in an emergency beyond the control of the member that requires the member to leave the meeting.
 - If a member is absent from more than 50 percent of a regular meeting, the member will be deemed absent and the absence will count against the member, unless the board, by rule, provides otherwise.
