- seeking the advice of its attorney about pending or contemplated litigation, settlement offers, or any matter in which the duty of the attorney to the City Council under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with the Texas Open Meetings Act. - deliberating the purchase, exchange, lease, or value of real property if deliberation in an open meeting would have a detrimental effect on the position of the city in negotiations with a third person. [Tex. Govt. Code §551.072]

## Rachel Rushing

Rachel Rushing is an artist originally from Louisiana now living in the Oak Cliff area of Dallas, TX.

Her work revolves around inclusive materiality, collaborative experiences, social and civil systems, and mediated environments which can manifest from photo-based installations to participatory making practices with an emphasis on cultural equity, intersectional feminist theory, and the ethics of artistic production.

Rushing graduated from the University of North Texas with a Master of Fine Arts in Studio Arts in 2014. She runs a social practice community space, Sunset Art Studios, in Dallas, Texas, has served as the Oak Cliff Earth Day Arts Coordinator for three years, co-hosts and produces the Art Funk Podcast, and works with community groups to promote civic engagement on a grassroots level.

## **Jeff Hurst**

Jeff Hurst has been a working artist, primarily as a lighting designer in the film and television industry, for 45 years, more than 30 years here in Dallas. In 1985 he cofounded Teatro Dallas, the Southwest's oldest Latinx theater organization, with Cora Cardona, and he has been active in the local arts community ever since. Along with others, he was an active participant in the writing of the original Cultural Policy, and subsequently in the development of the Latino Cultural Center. Most recently, he was appointed by Councilmember Scott Griggs to serve on the Municipal Library Board.

## Ofelia Faz-Garza

Ofelia Faz-Garza is a poet and {art}ivist from the Oak Cliff area of Dallas. She's inspired by the subtleties of life and uses her writing as a way to celebrate the rituals that root us. Her work crosses genres and has been included in several anthologies, including Women in Nature: An Anthology, Outrage: a Protest Anthology for Injustice in a Post 9/11 World, and tBASTA! 100 Latinas Speak Out Against Violence Against Women. She is the founder of the Meet Shop and the El Tallercito Writers Collective, and is a member of the DFW Latinx Writers and North Tejas Writers groups.
