**SUBJECT**

Recommendation in support of Legge Lewis Legge for the Bath House Public Art Pavilion located near the Bath House Cultural Center at 521 West Lawther Road in Council District 9

**BACKGROUND**

For the Bath House Cultural Center Public Art project, artist team Legge Lewis Legge was recommended by the Public Art Committee and the Arts and Culture Advisory Commission in January 2020, for a design development contract to collaborate with staff members from the City of Dallas Park and Recreation Department, Friends of the Bath House Cultural Center, and Office of Arts and Culture staff to develop a final Public Art plan for the Bath House Cultural Center Public Art pavilion. The outcome of the design development contract and work by Public Art staff was:

- Refinement of the concept design for the Public Art project that provides outdoor programming and presentation space for the Bath House
- Identification of installation conditions that needed further research
- Research on potential site condition issues and permitting; this research revealed that:
  - No geotechnical information exists, and the artist team will be required to complete a geotechnical report as a part of the fabrication contract in order to complete the engineering requirements for the fabrication contract
  - Building permits will be required as a part of the fabrication contract

The artist team made two presentations at the following community meetings:

- January 14, 2020 – the White Rock Lake Task Force recommended keeping the height of the pavilion as designed (13 feet high and on a concrete platform) and no larger.
- February 15, 2020 - a community presentation at Lakewood Library solicited no additional desired changes from the community

The artist team submitted a final Public Art plan including the final design, budget, site preparation, and installation plan on July 27, 2020

Following review of the final design, on August 11, 2020, the White Rock Lake Task Force made no additional comments.

**Artist Background**

Legge Lewis Legge (LLL), is an award-winning interdisciplinary collaborative focusing on art and architecture. LLL was founded in 2001 by architect Murray Legge, FAIA and cinematographer Deborah Eve Lewis, both based in Austin, Texas, and New York City-based artist Andrea Legge.

**Project Description**

The final design is for a pavilion on the north side of the Bath House Cultural Center, located more than 50 feet away outside of the Landmark designation zone. The pavilion will be constructed of textured concrete. The roof of the Pavilion is shaped to reflect the shapes of the boats found on White Rock Lake. The Pavilion will be on a concrete platform with a footprint of 39 feet by 16 feet, facing the lake. The lawn and beach in front of the pavilion will provide additional programming space or locations for viewing performances at the Pavilion.

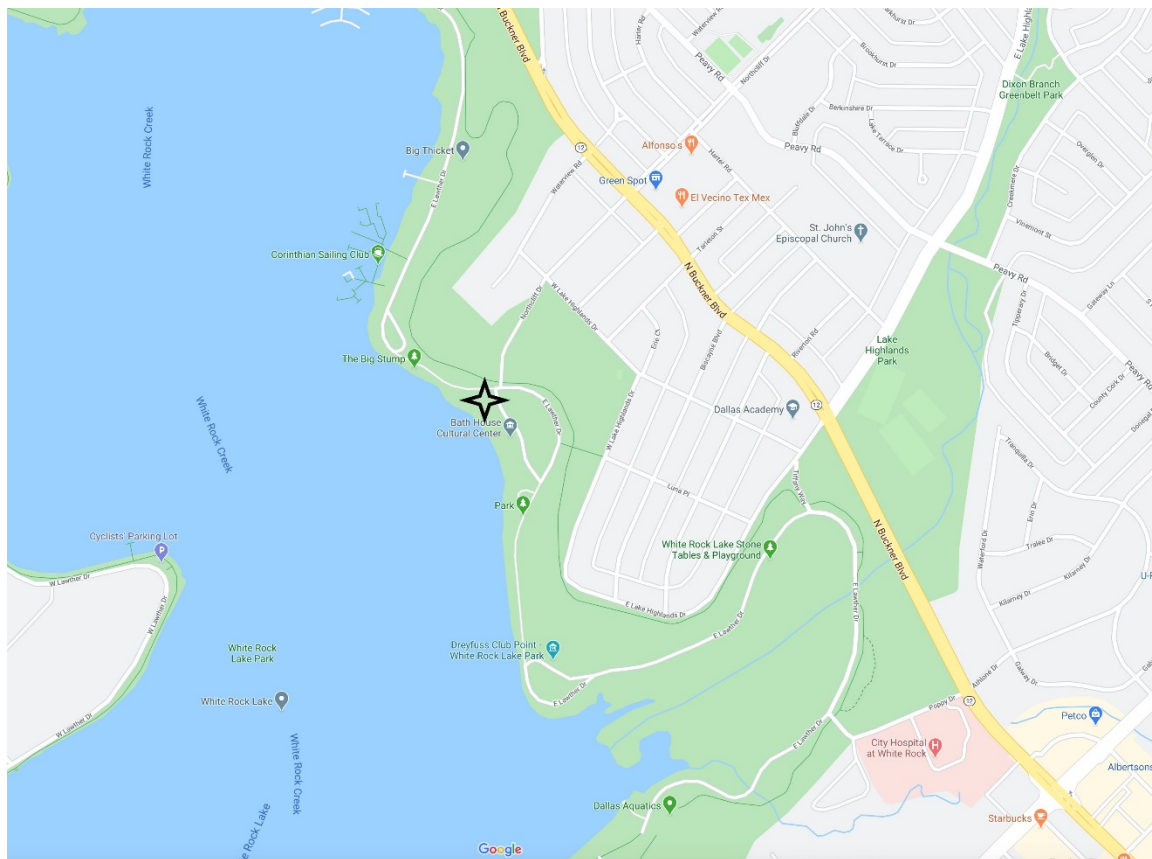

Recommendation in support of revised review criteria for Public Art depicting individuals or representing organizations in the City of Dallas Public Art Collection.

**BACKGROUND**

In September 2020, the Public Art Committee and Arts and Culture Advisory Commission recommended review criteria for Public Art depicting images of individuals or representing organizations in the City of Dallas Public Art Collection.

This action is to revise the review criteria to the below:

- Artworks that represent individuals or organizations who have made humanitarian and/or cultural contributions will be considered.
- At the time of accession and at a minimum of every 10 years, or in light of new information and support by a majority vote of the Public Art Committee, documentation of the contributions of individuals or organizations for any issues of inappropriate, unethical, or prejudicial actions or behaviors that are not acceptable in contemporary society will be reviewed.
- Special consideration will be given to artwork that promotes cultural and social equity.

The previously recommended review criteria are as follow:

- Consideration of artworks that represent individuals or organizations who have made ethical and humanitarian contributions.
- At a minimum of every 10 years or in light of new information and support by a majority vote of the Public Art Committee, review documentation of the contributions of individuals or organizations for any issues of inappropriate, unethical, or prejudicial actions or behaviors that are not acceptable in contemporary society.



- Special consideration will be given to artwork that promotes cultural and social equity.
