

## City: FY 22 Proposed & FY 23 Planned Budget



- City of Dallas overall FY22
   proposed and FY23 planned
   budgets are balanced and total
   \$4.35 billion and \$4.26 billion,
   respectively
- FY22 overall General Fund totals \$1.54 billion and reduces the property tax rate from 77.63¢ to 77.33¢ per \$100 valuation
- Additional resources of \$383.3M includes Federal ARPA funds





## Proposed FY 2021-22 OAC Budget Overview



- FY 2022 General Fund budget is up by \$1.1 million
- OAC's overall strategy is to rebuild operations and return services to pre-2020 levels, with continued emphasis on metrics that advance the long-term Cultural Plan goals
- Current year budget decreased venues budgets due to forecast COVID closures, and kept funding for cultural services contracts with artists and organizations as flat as possible



## **Budgeting for Equity**



- The 2018 Cultural Plan identified Equity as our top priority
- Budgeting for Equity for the FY 2022 City budget reflects the intentional process by departments to identify existing disparities in outcomes across various indicators and developing strategies and targeted investments to improve success for Dallas residents. The bullets below reflect a few of OAC's equity efforts in this budget:
  - Expand ALAANA artist contracting metric from cultural contracts program to cultural centers and venues to increasingly track investments in underserved communities of color
  - Establish the Juanita J. Craft House and Civil Rights Museum visual artist residency in South Dallas at the Mildred Dunn Recreation Center, to support the opening of the Craft House and Civil Rights Museum, and increase community vibrancy
  - Allocate financial and staff resources to mentoring next generation of ALAANA cultural workers through paid internship program



## Proposed FY 2021-22: Funding Programs



- Cultural Organizations Program (COP) is budgeted to increase by ~\$200K to \$5.16M – after being flat funded in current FY 2021 thanks to City Council amendments
  - Funding for Fair Park cultural organization added back into OAC; COP increase is in addition to this transfer
- ArtsActivate will return to \$775K across 3 rounds; current FY is \$600K, with supplemental funding from one-year Culture of Value funding from Arts Endowment
- Community Arts Program (CAP) is holding steady at \$410K; was kept whole in FY 2020-21 budget



#### Proposed FY 2021-22: Cultural Venues



- Programming budgets at all four cultural centers are back to prepandemic normal - \$86K at SDCC and LCC, \$63K at OC3 and BHCC
- Reallocation of internal resources adds programming and maintenance funds for the Juanita J Craft Civil Rights House and Museum; new coordinator slated for FY 2023
- Third theater technician added to Latino Cultural Center for new multiform theater, with additional maintenance and utilities funding
- Manager at Bath House Cultural Center restored with target hire date of 1/1/22
- Five paid interns added to contribute to developing diverse pipeline of technical and cultural workers

## **Allocations Committee Update**



- Allocations Committee is chaired by Chairwoman Ella Goode Johnson and members are Commissioners Mickie Bragalone, Jesse Hornbuckle, Priscilla Rice, Brad Spellicy, and Jo Trizila
- Allocations met on July 1 and August 5 to discuss upcoming year's COP and CAP applications
- FY 2022 COP scores and funding will continue to be analyzed by Allocations throughout August
- Formal FY 2022 CAP recommendation for funding was made on August 5, and contracting is currently underway
  - CAP contracts are all under \$30K, and like ArtsActivate, are recommended to the Director by Allocations to speed time to contract per Cultural Policy



## FY 2021-22 Cultural Organizations Program



- COP budget increased from \$4.9M to \$5.1M due to Hotel Occupancy Tax (HOT)
- 52 applications were submitted: 36 current COP organizations and 14 new
- African American Museum and Dallas Historical Society both completed applications in their first full-year return to OAC
- All returning organizations scored above the 70% threshold to remain in the program
- 7 new organizations in Tier 1 (\$100K-\$500K annual revenue) scored in the 90% range; all but one of the new applicants scored above 70% to qualify for funding consideration
- Per revised guidelines, organizations in Tier 1 will no longer be required to supply audited financial statements, which represents ~\$5-7K "savings"
- First virtual panels for Q&A with orgs were well-received by panelists and applicants
- 30 volunteer panelists generously reviewed applications scores are listed in the appendix

## Next Steps — COP 2021-22 year:



- Allocations will meet on August 19, August 26, and September 2 (tentative) to make funding recommendations to full Commission
- Commission will consider funding recommendations at the September 23 meeting
- Quality of Life, Arts and Culture will be briefed on COP recommendation on October 18
- City Council will consider COP contracts on October 27



## FY 2021-22 Community Artist Program (CAP)

- CAP budget has stayed steady at \$410K
- Current FY 2020-21 CAP received 51 applications and 44 artists were on the roster
- FY 2021-22 CAP received 60 applications, and 51 artists will be contracted based on scores of 80% or higher – a net increase of 7 artists
  - Roster (in handouts) consists of all 36 returning artists who applied and 15 new artists
- 24 volunteer panelists spent countless hours reviewing applications

## FY 2021-22 Community Artist Program (CAP)



#### Booking a CAP Artist:

- Step 1. Read Host Guidelines
- Step 2. Review CAP Roster online
- Step 3. Submit a CAP Request Form online with event details at least three weeks in advance
- Step 4. OAC staff will contact host to confirm artist availability
- Step 5. Contact artist to make finishing arrangements

Events must be free and open to the public. Events must occur within city limits of Dallas and must adhere to all listed guidelines.

- A member of a board or commission that is only advisory in nature may not hold over in his or her position longer than <u>nine months</u> after the expiration of his or her term or after the creation of a vacancy in his or her position – Dallas City Code Chapter 24 (13) (a)
