Recommend initiation of two public art projects as part of the Lemmon Ave Streetscape Enhancements in Council District 13

BACKGROUND

The Lemmon Ave Streetscape Enhancement project has been in the planning phase by the Department of Aviation for seven years. The current plan will provide safety and quality of life improvements on Lemmon Avenue in the vicinity of Dallas Love Field. These improvements will create a safe, walkable, bicycle and transit friendly Lemmon Avenue.

This project is the first phase of the larger "Love Field Loop Trail" project which will construct pedestrian and bicycle trails, enhanced bus shelters; streetlights and other improvements on all roadways surrounding Love Field Airport.

A design team (Kimley-Horn) and the Department of Aviation have identified two locations for artwork along Lemmon Avenue in Council District 13:

- 1) The intersection of Lemmon Avenue and Shorecrest Drive
- 2) The intersection of Lemmon Ave and Lovers Lane

On May 5, 2020 the Department of Aviation hosted a virtual public outreach session.

On February 3. 2021 the Public Art staff hosted a virtual community outreach meeting. A survey was available for one month on the OAC website for community input.

BACKGROUND

The Cultural Organizations Program (COP) provides funding for cultural services with established non-profit arts and cultural organizations to support an array of programs that include concerts, plays, exhibitions, performances, workshops, and other cultural services. The Office of Arts and Culture reviewed proposals from arts and culture organizations and completed administrative scoring.

Funding scenarios were reviewed by the Allocations Committee throughout the summer and were unanimously recommended by the Allocations Committee at a meeting on Thursday, August 26, 2021.

Due to funding availability, and high scores above 90%, seven new organizations were recommended for funding in Tier 1 (annual budget of \$100,000 - \$500,000). These organizations are denoted with an asterisk (*) below.

BACKGROUND

Information about this item will be provided to the Commission on September 23, 2021, and the resolution is attached. The resolution was requested by a member of the Allocations Committee and was unanimously approved by the Allocations Committee on August 26, 2021.

PRIOR ACTION/REVIEW

On February 4, 2021, the Allocations Committee of the Arts and Culture Advisory Commission voted to recommend the FY 2021-22 COP Guidelines.

On February 18, 2021, the Arts and Culture Advisory Commission voted to recommend the FY 2021-22 COP Guidelines.

On March 24, 2021, City Council voted to approve the original FY 2021-22 COP Guidelines.

On August 26, 2021, the Allocations Committee of the Arts and Culture Advisory Commission approved a recommendation in support of this item.

FISCAL INFORMATION

WHEREAS, the 2018 Dallas Cultural Plan and Dallas Cultural Policy place equity as the first priority of the Office of Arts and Culture; and

WHEREAS, on March 24, 2021 the City Council approved a resolution which authorized and established the FY 2021-2022 Cultural Organizations Program (COP) and COP Guidelines within the Office of Arts and Culture to support cultural services in the City of Dallas and approved the program guidelines, by Resolution No. 21-0499; and

WHEREAS, the COP Guidelines limit support of an organization to a maximum of 25% of an organization's prior year operating revenues in order to ensure that no one organization becomes overly reliant on this funding; and

WHEREAS, arts and cultural organizations in Dallas have experienced operating and financial difficulties due to the coronavirus (COVID-19) pandemic; and

WHEREAS, The Black Academy of Arts and Letters (TBAAL) experienced a revenue decline of \$1,473,015 (66%) and is allowed a maximum funding amount for FY 2021-2022 of \$186,450 by Resolution No. 21-0499, which represents a decrease on the FY 2020-21 COP contract amount of \$15,730; and

WHEREAS, Anita N Martinez Ballet Folklorico (ANMBF) experienced a revenue decline of \$69,528 (25%) and is allowed a maximum funding amount of \$53,250 for FY 2021-2022 by Resolution No. 21-0499, which represents a decrease on the FY 2020-21 COP contract amount of \$17,383; and

WHEREAS, TBAAL and ANMBF have a legacy of providing valuable cultural services representing important and underrepresented cultural traditions to a diverse set of Dallas residents;

Now, Therefore,

BE IT RESOLVED BY THE ARTS AND CULTURE ADVISORY COMMISSION OF THE CITY OF DALLAS:

SECTION 1. That a recommendation is made to fund TBAAL and ANMBF at their maximum funding amounts for FY 2021-22 allowed by Resolution No. 21-0499.

SECTION 2. That a recommendation is made to increase FY 2022-2023 COP funding for TBAAL and ANMBF, subject to an increase in demonstrated revenues by IRS Form 990 or audited financial statements, as allowed up to the maximum by any future City Council Resolutions related to COP.

SECTION 3. That any increase recommended for FY 2022-2023 COP contracts be allocated first to TBAAL and ANMBF, subject to the conditions above.

SECTION 4. That other increases for the FY 2022-2023 COP budget be made with special consideration to organizations with a history of presenting African, Latinx, Asian, Arab, or Native American (ALAANA) cultural traditions in line with the Cultural Policy of the City of Dallas, the Office of Arts and Culture's Equity Statement, and the Equity Goals of the Office of Arts and Culture.

BACKGROUND

Dallas City Code Chapter 2, Article X, provides for a Public Art Committee appointed to oversee quality control of the public art program and projects and to report to and recommend to the Arts and Culture Advisory Commission the scope of projects, artworks, and artists for the public art program. The Committee is composed of the three at-large members of the Arts and Culture Advisory Commission and eight members who are professionally qualified residents appointed by the Arts and Culture Advisory Commission.

In accordance with the Arts and Culture Advisory Commission Rules of Procedure Section 6(B), the nominees to the Public Art Committee have been verified by City staff to be eligible under the requirements listed therein, and proposed appointment terms are assigned to achieve a staggered rotation, spread as evenly as possible.
